The EOI period is open from 14 October to 11 November 2024. All EOIs must be submitted via SmartyGrants by **midnight** on **Sunday 10 November 2024.** 

Incomplete applications and/or applications received after the closing date will not be considered.

#### Eligibility Criteria

To be eligible for consideration in this EOI process, an organisation must:

- Be not-for-profit; or
- Be a registered charity;
- Be an incorporated body;
- Offer services that directly benefit residents of the Camden LGA; and

• Acquit any previous Camden Council grants (excluding grants held within the prior 12 month period) and have no outstanding debts to Council.


